

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$.224429 per \$100 valuation has been proposed by the governing body of Tarrant County for the Tarrant County Hospital District.

PROPOSED TAX RATE	\$0.224429 per \$100
NO-NEW REVENUE TAX RATE	\$0.225244 per \$100
VOTER-APPROVAL TAX RATE	\$0.243475 per \$100

The no-new-revenue tax rate is the tax rate for the 2021 tax year that will raise the same amount of property tax revenue for Tarrant County Hospital District from the same properties in both the 2020 tax year and the 2021 tax year.

The voter-approval tax rate is the highest tax rate that Tarrant County may adopt for Tarrant County Hospital District without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Tarrant County is not proposing to increase property taxes for the 2021 tax year for Tarrant County Hospital District.

A public meeting to vote on the proposed tax rate will be held on Tuesday, September 14, 2021 at 10:00 A.M. at Tarrant County Commissioners' Courtroom, 100 E Weatherford Street, Fort Worth, Texas 76196.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Tarrant County is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Commissioners Court of Tarrant County at their offices or attend the public meeting mentioned above.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

$$\text{property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by Tarrant County Hospital District last year to the taxes proposed to be imposed on the average residence homestead by Tarrant County Hospital District this year:

Enhanced Indigent Health Care Expenditures

The Tarrant County Hospital District spent \$385,290,670 from July 1, 2020 to June 30, 2021 on expenditures to maintain and operate an eligible county hospital. For the current tax year, the amount of increase above last year's eligible county hospital

expenditures is \$0. This increased the no-new-revenue tax rate by \$0.
