I. Call To Order

The meeting was called to order by the Planning Committee Chair, Trent Petty, at 10:43 a.m.

II. Hearing of Citizens

There were no citizens present to address the committee.

III. Approval of Minutes - January 12th 2017

Dr. Chuck Webber made the motion to approve the January 12, 2017 minutes. It was seconded by Charles Powell, and the motion was approved unanimously.

IV. Deliberations(s), Action(s) and/or Approval of Commercial Lease Agreement Tarrant County Hospital District and the Fort Worth Foundation Trust- S. Rule

Scott Rule asked for approval to submit the lease agreement between the Fort Worth Foundation and the Hospital District to the Finance Committee upon on approval of General Counsel. Mr. Rule said the location, next to the central resource facility for the homeless, is crucial for our patients. JPS will rent 12,737 square feet and the rest of the building will be occupied by human service agencies supporting the homeless population in Tarrant County. Robert Earley said this was just not a lease for us; this is directly in line to JPS mission. Dianna Prachyl said the clinic will double our capacity for our homeless patients. The JPS Medical Home at True Worth Place will have six exam rooms, plus multidisciplinary rooms, and will provide imaging services onsite. Clinic will dispense medications daily for our homeless population and provide lactation room education and clinical pharmacy support. Wound care services will be added in the future. JPS sees about 3,800 patient visit in a year in the current clinic on East Lancaster and should be able to expand to about 9,000 annually. The clinic will continue to be led by Dr. Frank Lonergan and a second provider, Dr. Victoria Lievano.

Dorothy Debose made a motion to approve submitting the lease agreement between Tarrant County Hospital District and the Fort Worth Foundation to the Finance Committee. It was seconded by Rev. Ralph Emerson, and the motion was approved unanimously.

VII. Deliberations(s) and/or Action(s) Regarding JPS Health Network Design & Construction Project Report – Angie Morgan

Angie Morgan presented the Design & Construction project status report on capital construction projects. The Northeast Tarrant Medical Home, which was approved by the City of Euless Planning & Zoning Committee on December 20, 2016 and will go before the City Council on January 24, 2017. Ms. Morgan will continue to provide updates to the committee as the project develops.

The Emergency Department Expansion Director will be here February 6, 2017. Radiology Equipment is in process. The Northeast Clinic clean-up will take care of the two vacant buildings. The Trauma APN is in design. This report is for informational purposes only and no action is necessary.
